**PROJECT LOCATION:** The project area is located south of the intersection of State Route (SR) 4 and Little John Road in the unincorporated community of Copperopolis. Copperopolis is located in southwestern Calaveras County, California, in the foothills of the Sierra Nevada. The 243-acre project site is located within portions of Sections 3 and 4, Township 1 North, Range 12 East, MDB&M on the Copperopolis 7.5 minute United States Geological Survey (USGS) quadrangle, and is designated as all or portions of Calaveras County Assessor's Parcel Numbers (APN) 061-003-001, 054-007- 003, 054-007-006, 054-007-018, 054-007-019, 054-006-030, -031, -032, and -037.

**PROJECT DESCRIPTION:** The proposed project would consist of the development of the 243-acre project site with urban uses, including mixed uses and several residential master planned communities. As planned by the project applicant, the Sawmill Lake project is designed to complement Copperopolis Town Square, a primarily commercial, mixed-use development that is partially constructed directly to the north of the site. To implement the project, the applicant has requested the following entitlements from Calaveras County; Amendment of the Calaveras County General Plan; Amendment of the Calaveras County Zoning Map; Adoption of the Sawmill Lake Specific Plan including the proposed Sawmill Lake Specific Plan Zoning Regulations; Approval of a Vesting Tentative Subdivision Map and a Development Agreement.

**RECIRCULATION:** Pursuant to section 15088.5 of the CEQA Guidelines, a lead agency is required to recirculate an EIR when significant new information is added to the EIR after public notice is given of the availability of the Draft Environmental Impact Report (DEIR), but before certification. Written comments are limited to only those sections included in the recirculation.

**SIGNIFICANT ENVIRONMENTAL EFFECTS:** The DEIR prepared has identified the following environmental issue areas as having potentially significant environmental impacts from implementation of the project:
